Our Santa Clara County Jail System Improving Outcomes and Saving Money

David Gonzales is Executive Director of Friends Outside in Santa Clara County, a non-profit organization that, since 1974, has provided general services to inmates in county jail facilities, and certain social services to inmates' families.

A Stanford graduate, Mr. Gonzales has a criminal justice background. He has a long career in law enforcement, rising to second in command of the Department of Corrections, the agency that operates the Santa Clara County jails.

At Friends Outside, Mr. Gonzales deals with programs that provide services to inmates, support inmates' families, and address the fact that seven out of ten children with incarcerated parents end up in the prison system themselves. Mr. Gonzales has many concrete ideas about how Santa Clara County taxpayers can realize more effective and efficient ways to address the problems associated with this vicious cycle.



What 95% of Republicans Don't Know about the Party

The Republican Party at the Local and State Level By Jan Soule

When you say "Republican Party" most people think of the RNC (Republican National Committee) headed by Michael Steele. From my experience people only think of the Republican Party every four years....this is a big mistake! We have lost control of our party because we have let "other people" take care of issues. You can have direct impact on the Republican Party at both the County and State level.

Santa Clara County Republican Party (<u>www.SVGOP.com</u>)

At the local level, your interests are represented by the Santa Clara County Republican Party. You are encouraged to attend the monthly meetings of the local party. They take place on the second Wednesday of the month at 7:00 PM at:

Santa Clara County Administration Building. 70 West Hedding Street San Jose, CA Isaac N. Senter Auditorium

The party is run by the County Committee which is elected every two years during the primary election and take office the following January. The members of the county committee elected the Executive Committee consisting of the Chairman, Vice Chairman, Secretary and Treasurer. Members are elected by county supervisorial district. You likely have voted for these individuals without having an idea of who they are and why you are voting for them. Ideally the local party is responsible for: 1)Recruiting candidates to run for local non-partisan offices like school board and city council; 2) Voter registration, 3) Recruiting volunteers and 4) Turning out the Republican vote. Doing a good job of turning out the Republican voters is very important....this enables candidates to focus on independents. The committee is only as effective as those that serve on the committee!

California Republican Party (www.cagop.org)

County Committees from the 58 counties in California send delegates to the semi-annual conventions of the California Republican Party. The spring convention takes place in a northern California city and the fall convention takes place in Southern California. This year, March 12th - 14th, the California Republican Convention (CRP) takes place at the Hyatt Regency Hotel in Santa Clara providing the ideal opportunity for Republicans in Santa Clara County to attend the convention. Any registered Republican in California can attend the convention as a guest. After paying the registration fee (it's been about \$60),you can attend workshops and general sessions. Guests have not voting privileges. Delegates, who do cast a vote, are appointed by the county committees and by various Republican organizations. You can also sign up (and pay!!) to attend various dinners and luncheons featuring noted speakers.

If you are interested in attending the convention in March, go to this link for more information. http://www.cagop.org/index.cfm/convention.htm. In addition to the informative workshops there is an exposition area with vendors and representatives of various organizations that you can become familiar with.

The convention is a great way to statewide candidates. All of the gubernatorial and senatorial candidates will be there. Governor Romney, who is supporting Meg Whitman for Governor, will be there as well.

More California State Taxes called "fees"

Schwarzenegger has brought back his 4.8 percent "surcharge" on homeowners and commercial property owners. Instead of cutting waste, inefficiency and fraud in the state's Department of Forestry, Schwarzenegger wants to take more money from families and business owners. And this tax (he deceptively calls it a "fee") is on top of last year's tax hikes (sales tax, income tax, car tax, and "child tax"). Tell Sacramento that you oppose bad ideas of raising taxes on property owners, smokers or anyone else in the future. Oppose the foolish idea of "borrowing" from municipalities.

SB810 State Controlled Government Health Insurance Passes the Senate

SB 810 prohibits Californians from purchasing private insurance, eliminates patient choice and would pass on an additional \$200 billion in costs to California taxpayers.

Parental Notification

Your help is requested to place the Parental Notification Amendment on California's November 2010 ballot. You can collect signatures on petitions from family and friends, and in your neighborhood, workplace and church building. It is perfectly legal for churches to ask people to sign petitions for this moral ballot measure in the sanctuary or the foyer. If you wish to support this ballot issue, you may request petitions, send an email with your name, mailing address and phone number to ParentalNotification@California.USA.com or leave a message with your contact information when you call 916-427-1671. Remember that in November 2008, the Parental Notification Amendment on California's ballot nearly passed, receiving 48.04% YES votes! Last February, a poll by the Public Policy Institute of California found that 68% of California adults support requiring parental notification before an abortion can be performed on a minor daughter. And with conservative voters motivated to turn out heavily this November, the odds are favorable to finally win this year, if only enough signatures can be gathered to qualify this important ballot initiative. Approximately 1.2 million rawcount signatures are needed by the first week in May.

Super Bowl Ad

Focus on the Family has purchased time during this year's Super Bowl broadcast to air a compelling pro-life ad featuring Heisman Trophy winner Tim Tebow and the decision his mother made 23 years ago to give birth to her unborn son when doctors were urging her to abort him. CBS has come under withering fire from the left for its decision to air this ad. Joy Behar of "The View" even said abortion would have been an appropriate choice since there was no way for Tim's mom to know that he wouldn't grow up to be a "rapist pedophile." The hypocrisy here is thick. Abortion proponents claim to be all about choice, but they are outraged over an ad that features a woman exercising her right to choose life for her baby son. Unfortunately, CBS sent a signal this week that it would be willing to accept "responsibly produced" ads that promote abortion or homosexuality. But a message that promotes death or sexual deviancy is not the moral equivalent of a message that celebrates life, and CBS must be urged to reject any such advocacy ads.

Take Action: If you would like to support this issue, you can E-mail CBS Chairman Les Moonves and CBS Entertainment President Nancy Tellem in support of their decision to air the Tebow Super Bowl ad. NEW AMNESTY BILL INTRODUCED —Provided by Carol Joyal

December 15 House Bill 4321 was introduced by Luis Gutierrez. The official name is "Comprehensive Immigration Reform ASAP Act of 2009", however some call it the "No Illegal Left Behind Bill" or the "Red Carpet Act". Nancy Pelosi has stated she wanted a bill to first come from the Senate, and most likely we will see one. The bill is almost 700 pages long, and it includes:

>.the Dream Act which would allow those who graduate from high school in the U.S. to be put on a fast track to citizenship,

- the Agricultural Jobs bill giving farm workers legal status,
- amnesty for people who came to the U.S. to bear citizen children,
- gutting state and local immigration laws,
- gutting the e-verification program to identify those eligible to work,
- generous amnesty provisions ,
- limited verification and background checks,
- limited border enforcement with sensitivity training for Border Patrol agents and,
- an increase in family and other legal immigration categories.

With fifteen million Americans unemployed, what an insult this is to our workers! How does a nation, heavily in debt, provide for the millions of additional people?

PROPOSED SVARW BYLAWS AMENDMENTS

ARTICLE III-MEMBERSHIP

ADD new category Section 5: ASSOCIATE membership may be conferred upon a registered Republican who supports the objectives and mission of the SVARW and who does not qualify for another membership category. Associate members shall not have voting privileges.

ARTICLE V-DUES Section 1. CURRENTLY READS; Annual dues for Active and Supporting members shall be recommended by the Executive Committee and approved by the Board of Directors. Members shall be notified of any change in dues at least 30 days prior to a vote by the General Membership.

AMMEND TO READ: Annual dues for Active, Supporting and ASSOCIATE members shall be recommended by the Executive Committee and approved by the Board of Directors. Members shall be notified of any change in dues at least 30 days prior to a voted by the General Membership.

ARTICLE VII-BOARD OF DIRECTORS

SECTION 1. CURRENTLY READS: The <u>BOARD OF DIRECTORS</u> shall be composed of the Executive Committee and the chairs of the following committees: Membership, Newsletter, Ways & Means, Member Communications, Legislation, Public Relations, Republican Affairs, and three (3) members at large appointed by the President and <u>approved</u> by the Executive Committee.

AMMEND TO READ: The <u>BOARD OF DIRECTORS</u> shall be composed of the Executive Committee and the chairs of the following committees: Membership, Newsletter, Ways & Means, Member Communications, Legislation, Public Relations, Republican Affairs, CANDIDATE DEVELOPMENT, and three (3) members at large appointed by the President and <u>approved</u> by the Executive Committee.

ARTICLE X-NOMINATIONG & ELECTIONS

Section 1: CURRENTLY READS: A Nominating Committee of five members shall be elected at the General Meeting in May.

AMMEND TO READ: A Nominating Committee of five members shall be elected at the General Meeting in JANUARY.


