

SVARW Statement on Proposed Government Healthcare Plans

The members of the board of Silicon Valley Association of Republican Women object to the current health proposals in the Senate and House of Representatives for the following reasons:

- 1. COST is determined by the non partisan Congressional Budget Office to be 1.3 trillion dollars. We don't know how this bill will be paid for without large tax increases and rationing of health services. Congress hasn't provided estimates so far.
- 2. A huge new BUREAUCRACY would result from a public option or single payer plan. There will be centralized decision making in Washington, and it will be harder to affect changes and decisions.
- 3. TORT REFORM is not addressed in current plans. Changing the current cost of malpractice insurance, and costly lawsuits, aren't a part of any plan we have seen. Tort reform is still needed so that potential lawsuits do not continue to cause doctors to order unnecessary tests.
- 4. The 49,000,000 UNINSURED NUMBER is OVERSTATED. It includes people in the country illegally, those who make over \$80,000, and others. The remaining uninsured could be covered in existing programs without a costly revamping of the entire healthcare system.
- 5. ILLEGAL ALIENS will be covered, despite denials by supporters of current bills. If one member of the family is eligible, the whole family would be eligible for a public option. Congress rejected an amendment that would require secure ID.
- 6. Cutting MEDICARE by 40 percent, in order to help finance a national healthcare plan, would affect care for seniors. It is becoming harder in our area to find doctors who will accept Medicare patients.
- 7. EMPLOYER MANDATES would perhaps be another potentially costly factor in putting Americans back to work and sending more jobs abroad.

8. Abortion and sex change operations would be included in H.R. 3200.

Legislation, Barbara Wales Chairman

This summer has been dramatic in the legislative area. Congratulations to everyone who participated by calling, writing, emailing, attending Town Hall Meetings, and making your thoughts known! Thank you also to those who have contributed stamps and money to cover our letter writing costs.

Health Care Bill(s)-Socialized Medicine

There is lots of information on this so we'll save the space here. However, it is important to know that a scaled back version -in whatever form it takes-will open the door to ALL of the other provisions being added piecemeal in separate bills or attached to other bills. Please let your representatives know how you feel and keep the pressure on.

Health Care – Forcing Support by Intimidation

Congressman Waxman (D-CA) has requested the travel expense records from the top executives of the seven largest insurance companies for the last 7 years. This is clearly pressure on these companies to support the democrat socialized medicine proposal. Beyond this one issue is the concept that Congress can pressure support by threats. We need to let our representatives that we object to this type of action. Please write your representatives in Washington and object to this action.

Prop 8 Attack

SB 54, authored by homosexual activist and Democrat state senator Mark Leno, would violate the clear reading of the Constitution by recognizing pre-Prop. 8 homosexual "marriages" from other states and nations -- Massachusetts, Belgium, Canada, Netherlands, Norway, South Africa, Spain and Sweden -- as fully-valid "marriages" in California. Please contact your state senator by email and phone. The implications of this action go far beyond just this constitutional amendment -the Legislature is clearly acting contrary to the vote of the people.

Update on action against Prop 8: On January 11, the court will hear arguments about whether Proposition 8 was based on discrimination against homosexuals. Several homosexual organizations had sought to intervene in the case, but all were denied participations except for the City of San Francisco, which argued a direct impact on their citizens resulting from Proposition 8's passage. Chief U.S. District Judge Vaughn Walker also scheduled a hearing for October 14 to consider some pre-trial issues such as what constitutes discrimination under the Constitution.

Second Amendment Rights (contributed by J.P. Puette)

Senate Bill SB-2099 will require us to put on our 2009 1040 federal tax form all guns that you have or own. It may require fingerprints and a tax of \$50 per gun. This bill was introduced on Feb. 24. This bill will become public knowledge 30 days after it is voted into law. This is an amendment to the Internal Revenue Act of 1986. This means that the Finance Committee can pass this without the Senate voting on it at all.

Harvey Milk Gay Day

SB572 is making its way through the legislature and is likely to land on the governor's desk. The bill has our school children, as young as kindergarten, participating in activities to honor the gay lifestyle. California Legislative Resolutions

The legislature has also introduced three resolutions that assault family values. Although resolutions are not binding, they express the intent or opinions of the legislature, and therefore the represented opinion of California's citizens. However, these three resolutions do not represent the will of voters who have repeatedly rejected the aggressive homosexual agenda.

AJR 13 "encourages" the President and the Secretary of the US Department of Health and Human Services to repeal the current FDA ban on homosexual blood donors. This is a dangerous appeal that could result in health risks for innocent blood transfusions.

AJR 15 "encourages" Congress to pass and the President to sign the Uniting American Families Act, which will allow United States residents to sponsor their same-sex partners for legal immigration. However, the Defense of Marriage Act (DOMA) specifically defines marriage as being between one man and one woman. For family members to immigrate to America, they must be family by blood, marriage, or adoption. The Uniting American Families Act seeks to make an exception to this rule and undermine the important DOMA policy of protecting marriage.

AJR 19 calls upon Congress and the President of the United States to repeal the Defense of Marriage Act. Like California, federal law recognizes only traditional, heterosexual marriage. Last November millions of Californians, for the second time, voted to protect the traditional definition of marriage being between one man and one woman. Yet the California Legislature has repeatedly attempted to thwart the people's decision. AJR 19 does not express the beliefs of the majority of Californians, who support traditional marriage protection in our state and our federal government.

Call your Assembly member and Senator and tell them to vote NO on AJR 13, 15 and 19.

California Bills

September 11 is the last day for bills to pass the legislature and go to the governor. That means the next two weeks will be a busy time for the legislature.

There are several bills that attack the initiative process, which has proven a valuable tool for voters. Please call your legislators and urge them to vote NO on these attacks on the initiative process:

SB 34-Restricting Paid Petition Gathering (Corbett)

This bill would create a new crime, by making it a misdemeanor for anyone to pay or receive anything of value, based on the number of signatures obtained on an initiative, referendum, or recall petition. In Assembly; will be voted on at any time.

AB 6 - Requiring Initiative Circulators to Register with Government (Saldana)
This bill would require any professional petition firm, which pays people to circulate and collect signatures for petitions to place initiatives on the ballot, to register with the Secretary of State. In Senate: will be voted on at any time.

AB 436-Making Initiative Ballot Qualification More Expensive (Saldana)

This bill would increase the initiative fee to \$2,000, making it very expensive for organizations or citizens to file their initiative. In Senate; will be voted on at any time.

AB 1068-Prohibiting Paid Petition Gathering (Saldana)


AB 1068 would prohibit contracts for circulating petitions and gathering signatures for those measures that make payment contingent upon the measure qualifying for the ballot. In Senate; will be voted on at any time.



Banning Plastic Bags Fee for Paper Bags
