## Legislation Continued....

#### **SVARW Candidate Endorsement**

Since it's an election year, your Board thought it might be beneficial to reiterate SVARW's Candidate and Issue Endorsement Policy. Unlike many other Republican organizations, SVARW is able to endorse candidates in the primary, is able to endorse a non-Republican, and does not automatically endorse a candidate in the general election just because it says "Republican" after the name.

The major reasons for endorsing are 1) the candidate stands for those positions on most issues which most of our members support, 2) the candidate will benefit from our endorsement, 3) SVARW will take actions to support the candidate. Lack of endorsement does not mean that most SVARW members will not vote for a Republican candidate, but rather that they do not meet our criteria for outstanding candidates to work with (see #4 below also).

<u>Any member</u> may recommend endorsing a candidate or issue. The recommendation must be in writing and submitted to The Legislation Chairman or Officer for presentation at the Board Meetings (usually held the last Wednesday of each month). The recommendation should include:

Candidate's name and office and the candidates who are running against them. A statement as to why this candidate is the one who should be endorsed by SVARW (his/her stands on issues, voting record, etc.) If it's an issue, indicate both sides of the issue.

Has the person spoken at SVARW so members had a chance to ask about the candidate's positions and qualifications? (This requirement can be waived if the candidate and the candidate's positions are well known.) For an issue, has someone spoken on it at SVARW?

What benefit would it be to the candidate (or issue) to receive an SVARW endorsement? What are you personally willing to do to support the candidate (or issue)? (Chair an SVARW fundraiser for the candidate, run a voter registration drive in the candidate's area, work on having a series of neighborhood coffees for the candidate, etc.) This is especially important because a major consideration for the Board is that SVARW be ready to actively support our endorsed candidates.

SVARW will review, for endorsement, all Honorary Members, General Members and Supporting Members who are running for office as early as possible.

The Board will vote on the endorsements which are scheduled on the Board Agenda at the Board Meetings. Candidates received letters of endorsement when endorsed. Endorsements appear in the Newsletter.
