



The annual SVARW Christmas Brunch is taking place on December 10th. The event features:



Proposition 8

The Court denied requests to stay enforcement of Prop. 8, meaning that the voters' rejection of gay marriage will stand—at least for a few months. The Court has now requested briefing on three issues: whether Prop. 8 is a "revision" of the state constitution which cannot be achieved through the initiative process; whether Prop. 8 violates the "separation of powers;" and what effect Prop. 8 would have, if it is upheld, on the gay weddings performed before its adoption. The Court has asked for briefing from Attorney General Jerry Brown and the official proponents of Prop. 8 by December 19, with amicus briefs due on January 15. The Court will hear oral arguments sometime in early 2009.

We fought for Prop 8 and won, but now we have to fight again. Ask your public officials to uphold the will of the people.

And demand that same-sex "marriage" backers stop their terrorist tactics.

Action: Please contact Gov. Schwarzenegger, your state assembly member and state senator. Ask them to encourage the California Supreme Court to uphold the state Constitution and the amendment passed by a majority of the California people. As you can, please contact as many other California legislators as possible. Mail as the Gov. claims he reads all non formed letters. Also call, fax or e-mail (information below).

The California Supreme Court has overturned the votes of 4.6 million California voters once. We voted <u>again</u> and now many of our own leaders are encouraging the Court to overrule more than 6.4 million Californians! They are also giving tacit encouragement to the mobs of demonstrators who are wreaking havoc in our streets, often with intimidation and sometimes with violence. On CNN, last Sunday, **Gov. Schwarzenegger**, who twice vetoed legislation to institute gay marriage, urged the opponents of Prop 8 to continue their fight. "They should never give up, he said in the interview. "They should be on it and on it until they get it done."

Your Message

Please be firm but polite - our opponents have not always been. Your message can be something like this, only in your own words plus as much information as you can come up with. What the Gov. is doing is not what the majority of the people of California want.

I voted to support Prop 8 and restore the definition of marriage as between a man and a woman. This amended our state Constitution. More than 6.4 million Californians voted similarly. You have taken an oath to support and defend our Constitution, and you represent me. Please support the will of the people and ask the Court to uphold our decision. Further, please ask the opponents of Prop 8 to cease the campaign of intimidation and violence that has characterized too much of their "civil disobedience." They need to respect the democratic process.

Also tell the Gov. that you voted for him and that you were glad when he made statements that he would not go against the people who voted for Prop 22. Ask him why he changed his mind. Tell him about the problems they have with the children in countries where they have allowed homosexual marriage.

Legal Challenges

Proponents of Prop 8 have asked the Court to allow them to intervene and provide representation for the amendment. Attorney General Jerry Brown will represent voters in the cases, but he can hardly be expected to mount a strong defense when he changed the ballot language midstream to biased wording that was nothing short of sabotage. Similarly, the governor continues to urge same-sex "marriage" proponents to "never give up." "The whole point of the initiative process is for the people to be able to pass laws despite opposition from government leaders. It just makes no sense that we should have to rely solely on hostile government leaders to defend the will of the people when they opposed the measure in the first place."

PROPOSITION 4

Prop 4's attempt to pass parental notification prior to a minor's abortion fell just short of voter approval for the third time. Sponsors have indicated that they will try again. Opponents push the fact that parents might beat the girl for getting pregnant, but there is no registered proof of that. Plus this time the bill stated that the girl could tell any member of her family, it did not have to be her parents.

A FEW THINGS TO LOOK FORWARD TO IN THE FUTURE

We now have the most pro-abortion president in history. Obama has said that he will rescind Pre. Bush's ban on partial birth abortion and he voted 4 times to let a baby die on a table if an abortion was botched and the baby is born alive. This is the Infant Protection Act. He has said that he will also rescind Pres. Bush's executive orders that prevent federal funding (our tax money) for international abortions. Obama will also allow the use of embryonic stem cells for scientific research even though they have had success with adult stem cells.

Obama has placed Henry Rivera a radical leftist as the new FCC commissioner. He strongly supports the "Fairness Doctrine" which will rid us of conservative and Christian radio stations. If you would like to sign a petition regarding this issue go to alert@mrcaction.org.

By switching to Tiger, customers could save up to 10% on their annual natural gas bill. Since 1997, CA. law has permitted people to switch to a different supplier of natural gas.

NOTE

Tiger supplies only natural gas. For electricity we are still captive of PG&E.

What is identity theft?

Identity theft occurs when someone uses your personally identifying information, like your name, Social Security number, or credit card number, without your permission, to commit fraud or other crimes.

The FTC estimates that as many as 9 million Americans have their identities stolen each year. In fact, you or someone you know may have experienced some form of identity theft.

The crime takes many forms. Identity thieves may rent an apartment, obtain a credit card, or establish a telephone account in your name. You may not find out about the theft until you review your credit report or a credit card statement and notice charges you didn't make—or until you're contacted by a debt collector.

Identity theft is serious. While some identity theft victims can resolve their problems quickly, others spend hundreds of dollars and many days repairing damage to their good name and credit record. Some consumers victimized by identity theft may lose out on job opportunities, or be denied loans for education, housing or cars because of negative information on their credit reports. In rare cases, they may even be arrested for crimes they did not commit.

SUPPORT STILL NEEDED FOR E-VERIFY

Our lame-duck Congress authorized renewal of the E-Verify system for only six months. This is an internet-based system, authorized as part of the 1986 amnesty that allows employers to quickly confirm the legal working status of new hires. In March, E-Verify will have to be renewed or this effective system will die.

Some employer groups are fighting renewal because they suspect they have illegal workers and claim they need them. They also allege the system is inaccurate. The process could allow an employee to use stolen identification. If a worker has changed his name, changed his visa status, or inaccurate entries are made, a trip to the Social Security office is required to make corrections. An employer has to allow workers an eight day period to do this.

President Bush signed an executive order that requires all federal agencies and federal contractors to use E-Verify for new hires. We do not know if the new administration will change the rules or will support an extension of the program. At one point, Senator Obama did support extension of E-Verify. Please remind your member of Congress of the urgent need to renew this valuable system.

ACTION: Contact your House and Senate members and urge that E-Verify be renewed for five years. E-Verify reduces the incentive for workers to enter the country illegally or overstay a visa.
