

### Legislation

Legislation, Barbara Wales Chairman

The major focus of our efforts this month has been on the May 19 Election. Thank you to everyone who voted and who encouraged others to vote! This was a tremendously expensive election which could have been avoided if State lawmakers had been doing their jobs. No wonder we have a budget crisis!

#### **Harvey Milk Day**

SB 572 which designates May 22 as Harvey Milk Day as a day on which "Exercises remembering the life of Harvey Milk and recognizing his accomplishments as well as the contributions he made to the state" should be conducted and specifically, "all public schools and educational institutions are encouraged to observe...and ...conduct suitable commemorative exercises." A statewide poll by Survey USA in early March found that 69% of the people in the State oppose this. Only 19% supported it. A majority of Democrats, Independents, Republicans, liberals, moderates and conservatives all said "no." So why is the Legislature trying to force this on California?

Action: Please call Governor Schwarzenegger at 916-445-2841 and say "I want the Governor to announce he will veto SB572, Harvey Milk Gay Day in schools, like he did last year. Parents don't want this non-academic promotion of alternative sexual lifestyles to children as young as kindergarten. Most Californians are opposed to this being pushed on children! Veto SB572!"

#### The Bag Tax

We need to let the San Jose City Council know that we oppose it because 1) cloth bags can be unsanitary and actually cause disease, 2) cleaning canvas bags after every use uses so much water and detergent that it is worse for the environment than plastic bags, 3) plastic bag recycling has been very successful and is growing, 4) studies have shown that when people don't have plastic bags from groceries that they buy considerably more plastic bags and this hurts the environment, and 5) in Oakland, a judge struck down a plastic bag ban as there was no evidence it helped the environment.

#### **ACTION**

Please call or email San Jose City Council Members and the Mayor. Even if you don't live in San Jose, if San Jose votes for it, it is likely smaller cities will follow suit.

#### **Proposition 8 Upheld by Court**

Prop 8 was upheld; although 18,000 "marriages" which were performed before the Nov. 4 vote were deemed to be legal. *Thank you to Claudette Averill who has worked so hard on* this!

#### **Proposition 8 by Claudette Averill**

#### Marriage Upheld in California

The California Supreme Court upheld Proposition 8, the state marriage-protection amendment approved by voters last November. This is wonderful news and, ironically, the court that affirmed the amendment is the very one that originally legalized same-sex marriage last year. Perhaps these judges are finally realizing that it's their job to interpret law, respect the will of the people and not create law. The judges stated that this was not their personal wishes. Eighteen thousand homosexuals will remain married which would not have occurred if these same judges had not over stepped their rights and legalized their married last May. Evidently our governor does not understand the will of the people and Prop 22 as he wrote a letter to the judges asking them to over turn the Prop 22 statute which they did. The governor has also told the homosexuals not to give up, which they are not. Those whom oppose Prop 8 are going into parts of CA. that voted strongly for Prop 8 and are working to change their minds. The next step will be to do what we did and get a million signatures to put it on the ballot again. Each time we vote there are less people voting for a man, woman marriage.

#### **Across the Nation**

lowa, Maine, Vermont, Massachusetts, and Connecticut now recognize same-gender marriage, that right likely will be challenged in lowa and Maine. In the last decade, in 30 of the 30 states where marriage has been on the ballot, the people have protected marriage as only between a man and a woman.

Californians will need to remain vigilant to protect marriage, their parental rights, and their religious freedoms. Ron Prentice, chairman of the protectmarriage.com coalition said, "We will turn our attention to public education and outreach so that citizens come to better understand and appreciate the many benefits that traditional marriage provides for society and our families."

I was very proud of not only SVARW but all religions that came together in the Santa Clara County to fight for marriage.

#### Marriage Praised at the UN

I'm also excited to share with you about a lunch briefing Focus on the Family hosted earlier this week at the UN Headquarters in New York. About 60 ambassadors and diplomats gathered to hear from experts who explained that kids thrive best when raised by their married mom and dad. This was a significant message for the ambassadors to hear, as they are being asked to protect homosexuality as a basic human right. The speakers included Mr. Lee Wee Min, regional director for Focus on the Family Asia, as well as Philippine Ambassador Hilario Davide, who spoke passionately about God's design for marriage as the union of a man and a woman.



#### **NEWS BITS**

Gallup Poll indicates that 51% of Americans consider themselves Pro-Life as opposed to 42% who consider themselves Pro-Choice. This is the first time the majority of Americans have answered they are Pro-Life. However, the President is pushing to reverse the ban on late term abortions and there is pressure in the Republican Party to have the party drop any stand on abortion.

#### Hate Crime Legislation

HR1913 passed in the House and is expected to be considered by the Senate after Memorial Day. It gives special protections to individuals based on their "perceived" sexual identity or gender identity. It passed by 249 to 175 along party lines.

Two major issues with this bill are 1) it provides UNEQUAL protection under the law – the US system of justice is based on EQUAL penalties for the same crimes) and 2) this could impact freedom of speech – consider a pastor in a religion which believes marriage is between a man and a woman.

#### Rep. Zoe Lofgren Slanders House Witness

April 1, 2009 Rep Lofgren was chairing a House Judiciary sub-committee on an immigration issue. Some committee members tried to keep constitutional lawyer, Kris Kobach, from testifying, using allegations of racism from the Southern Poverty Law Center (SPLC), and based on association with immigration reform groups. Rep. Lofgren read the slanderous letter into the Congressional Record without questioning its content. Mr. Kobach has been very successful in lawsuits supporting immigration enforcement issues, and this was payback time. If you go to <a href="https://www.splc.org">www.splc.org</a>, you will find a map of hate groups. One group that has a symbol is marked "Christian identity". Their definition of a hate group is that they "have beliefs or practices that attack or malign an entire group of people". I'm not sure how "Christian identity" fits into this definition, but apparently Ms. Lofgren, an attorney, supports this kind of tactic. #### CALIFORNIA TAX PROTECTION ACT OF 2010

This is a new California initiative measure to address the problem of "birth tourism" sucking up our welfare tax dollars. The United States is the only first world country that allows visitors and illegal entrants to give birth here to citizen babies. It is estimated at least 400,000 instant citizens are born here yearly. Even births in our territories to are citizen births, increasing the financial and population problems. The 14th Amendment, written to give former slaves citizenship, needs to be interpreted by the Supreme Court. This initiative would require alien birth mothers to apply in person for a "Birth to a Foreign Parent" certificate. Mothers would have to supply identity documents and fingerprints. This information would be made available to Immigration and Customs Enforcement (ICE). No doubt the Federal Ninth Circuit Court would strike the measure down. This offers an opportunity to appeal all the way to the Supreme Court. Will this Court have the courage rule on this issue?
