



#### President's Memo

Summer is here, and the political season is in full swing. The unemployment rate has increased to 8.2%, and there is no "hope" of "change" until the November election. For those of you who think that Mitt Romney is not conservative enough, I strongly urge you to ponder this chart:



Almost anyone would be more conservative than the present occupant of the White House, and I hope that we can all coalesce around the Romney nomination and work for his election. #### May 12, 2012 Liberty Celebration with Sheriff Richard Mack

SVARW held its annual Liberty Celebration at the Elk's Lodge in Los Gatos May 12 with Sheriff Richard Mack as the keynote speaker. Also speaking was Karen Meredith, President of the Northern California chapter of American Gold Star Mothers (AGSM.)

Sheriff Mack spoke on "Local Solutions for National Problems." In a very interesting presentation, he described how he and six other sheriffs challenged the constitutionality of the controversial Brady Bill and won in a 5-4 US Supreme Court decision.

Sheriff Mack is a self-described "constitutional conservative" with a long history of supporting causes such as states' rights, individual rights, and Second Amendment rights. His is an ongoing quest for defending and restoring liberty.

Also, as part of the program, SVARW honored American Gold Star Mothers, a national group of mothers whose sons and daughters died while serving

our country. Karen Meredith accepted the award on behalf of American Gold Star Mothers and shared with us her own personal story as well as an overview of AGSM.

California is in a depression .... We have AB 32 [cap and trade] and SB 375 [greenhouse gas reduction] adding billions to the cost of California businesses.

#### CA Debt Much Larger Than Reported

Reports of California's debt usually just include the \$17 billion budget deficit. But California also owes the federal government \$14 billion and public schools \$10 billion.

"While California sputters under the massive debt, legislators continue to take up ridiculous bills and resolutions, and ignore bills which would begin necessary reforms. ... the Assembly voted ... September 2012 as National Coupon Month [to] "... acknowledge the value of coupons in achieving significant savings for CA consumers." [Assemblyman Felipe Fuentes, D-Sylmar]

While this trivial resolution sailed through, many ... Republican bills sit stuck in the Rules Committee or are unceremoniously killed [in] the Appropriations Committee, led by Fuentes.

Assemblyman Brian Nestande, R-Palm Desert, has re-introduced <u>ACA 13</u>, a constitutional amendment to give the State Controller the authority to approve the budget. <u>ACA 13</u> would prohibit the Legislature from sending to the Governor a Budget Bill in which General Fund appropriations exceeded General Fund revenues as determined by the Controller."

#### Green Corruption: Department of Energy "Junk Loans" and Cronyism, Part One

Gene Koprowski of *The Daily Caller* unleashed the most outrageous part of the House Committee on Oversight and Government Reform investigation: "Obama energy officials funded solar firms despite 'junk bond' ratings from S&P and Fitch." Koprowski detailed the DOE's lack of caution in backing hundreds of millions of dollars in loans for "tainted solar power projects."

In fact, the report released last month by the committee, led by Darrell Issa (R-Cali.) "painted a startling picture of mismanagement at DOE." ... of the 27 loan guarantees under the 1705 Program, ... "23 ... were "junk grade" due to their poor credit quality, while the other four were rated BBB, ...the lowest ... investment ... grade." [Twenty-three of 27 loan guarantees is 85%!]

According to Issa's Team, the DOE's 1705 loan portfolio overall average was BB-. "Now, I'm no financial guru, but I wouldn't want that grade on my report card." Political buddies indeed - 21 energy firms are behind the 27 projects found in the House oversight investigation; 18 ... are politically connected to President Obama (15 alone) and the Democratic Party, [also] over 85%!

"I think it's a bad idea," said Sen. James Inhofe (R-Okla.). "I don't like to do something in the lame-duck session, particularly something that is as dangerous to our sovereignty as this is."

## Why the CLASS Act Initiative is needed to Repeal SB 48



How it became law

SB 48 made its way through the legislature and was signed into law by Governor Brown in July 2011. SB 48 mandates implementation of this bill on January 1, 2012.

What it does

SB 48 uses all social science curriculum, including history books and other instructional materials, to teach children as young as five not only to accept but also to endorse transgenderism, bisexuality, and homosexuality. SB 48 has been misrepresented to the public and passed as a bill aimed to end bullying. SB 48 went into effect January 2012. Under SB 48, public schools will begin supplementing current instruction with pro-transgender, bisexual and homosexual materials before textbooks are revised. If schools do not comply with this they are in violation of the law.

Fortunately, there is another way to get rid of this overreaching and inaccurate teaching of history. Sign the petition, pass the CLASS Act.

#### What you can do

Our public schools are academic institutions, not a place for politicians to force their radical agenda on children. SB 48 does absolutely nothing to reduce bullying, improve the state of our education system, ensure students graduate, or prepare them for global competitiveness. Instead it diverts precious classroom time and resources away from science, math, reading, and writing to promote the political agenda of a few.

Stop SB 48 supporters are rallying together to repeal this law through the initiative process. An Initiative called the CLASS (children learning accurate social science) Act has been filed. This initiative demands the accurate teaching of history. With this initiative in place no person will be left out because of his or her sexual preference, but rather their contribution to history will be the focus not their sexual preference. We must gather 700,000 signatures to qualify this initiative for the ballot. You can get involved by signing the petition.

#### Overseas Coupon Program

Send your coupons to soldiers overseas! This program serves military families by assisting us to forward "manufacturer's coupons" to the U.S. Navy base in Gaeta, Italy.

These bundles of coupons are placed on tables, at the PX and Commissary, or handed out for use by military members and families on base. This helps a military family save valuable dollars and stretch their budget. Please follow these four easy steps:

- 1. Clip your "manufacturer's coupons" with expiration dates that are no more than one month past their expiration date.
- 2. Please sort your coupons into "food" and "non-food" bundles and place them into Ziploc baggies.
- 3. Tally the dollar total for each bundle and mark on each baggie with a felt tipped pen.
- 4. Bring them to the next SVARW meeting.

Remember: the magic words are "manufacturer's coupon". Do not send restaurant coupons, assistance vouchers, food stamps, or any other assistance items, which generally have a personal name on them or are issued for a specific person to use. Do not send store coupons, which are only good at the store named, and cannot be used on a military base overseas.
