

The Bag Tax

The Santa Clara County Commission, after having adopted a policy focused on education and not a bag tax by a unanimous vote 2 months ago, voted again and adopted a policy recommendation for local governments to ban plastic and place a fee on paper.

The issue will come before the San Jose City Council on June 2nd (this can change). We must act now to stop this nonsense!.

SPECIAL ELECTION IN CALIFORNIA MAY 19TH

VOTE NO 6 TIMES

RECOMMENDATIONS FROM ASSEMBLYMAN CHCUCK DEVORE

I am voting "no" on all six ballot measures. As a member of the California Republican Party's Initiatives Committee, I also voted in favor of opposing all six measures, a stance the state party formally adopted the day after the Initiatives Committee vote. Below, I explain why.

Prop 1A

How they describe it: "STATE BUDGET. CHANGES CALIFORNIA BUDGET PROCESS. LIMITS STATE SPENDING. INCREASES "RAINY DAY" BUDGET STABILIZATION FUND."

THE TRUTH: Prop. 1A is the most important measure. It would extend the largest state tax hike in U.S. history by an additional two years. This is not mentioned in the ballot arguments because the legislative leadership chose to ignore the ballot argument I submitted against this measure (I was one of only five Republicans in the legislature to oppose this measure on the floor). Prop. 1A, a weak, loophole-ridden budget reform measure, is twinned with a huge and hidden tax extension – this is dishonest and should not be rewarded.

Props 1B through 1E

How they describe it: EDUCATION FUNDING. PAYMENT PLAN; PROPOSITION; LOTTERY MODERNIZATION ACT; CHILDREN'S SERVICES FUNDING; HEALTH SERVICES FUNDING

THE TRUTH: Measures 1B through 1E amount to a shuffling of the deck chairs on the Titanic – they do nothing to reform government so it can live within our means to support it.

PROP 1F

How they describe it: ELECTED OFFICIALS' SALARIES. PREVENTS PAY INCREASES DURING BUDGET DEFICIT YEARS.

THE TRUTH: Beware of Prop. 1F, it supposedly prevents pay increases for lawmakers during a budget deficit. The law of unintended consequences says that lawmakers may simply vote to increase taxes to try to erase any deficit and keep their pay increases.

Obama Appointments by JP Puette

Republican Senators need to be encouraged to filibuster the nomination of David Hamilton to the 7th Circuit Court of Appeals. He is a former Fund Raiser for ACORN and when Clinton nominated him in the 90's the American Bar Association found him "not qualified". He is openly pro-abortion and does not pretend to take a neutral position. (Note: This is the appointment which we discussed at the April Meeting: Hamilton also ruled that the Indiana Legislature must discontinue its 188-year tradition of opening legislative sessions with prayer. The suit was brought by the ACLU and he was a Board Member of the ACLU prior to becoming a judge. He also ruled that public prayer could not contain the words "Jesus," "Savior" or "Son" but could contain "Allah." (This was directly against the US Supreme court ruling that the court could not dictate the language of a prayer.) Other troubling rulings he has made relate to illegal drug possession and the ability of child sex offenders to move freely within a state. Please see his record for more information.)

Harold Koh has been nominated as the Legal Advisor to the State Department. This position is very important and affects how the U.S. deals with legal issues in the world. He is a firm believer that international law should be taken into account in U.S. court decisions and also believes that Sharia law has a place in the U.S. He has total Transnationalist views.

The third appointment that Obama has made that needs to be fought is that of Rosa Brooks as a Pentagon Advisor. She would advise someone who is deeply involved in National security and in shaping policy in places like Afghanistan. She was a writer for the Los Angeles Times and has written awful things about President Bush and the previous administration. At one time she worked for George Soros.

ACTION: Call Republican Leadership and tell them to filibuster these appointments

DREAM ACT IS ANOTHER ILL-ADVISED AMNESTY

As our local colleges are cutting admissions, along comes Congress again trying to pass an amnesty for illegal entrants who graduate from our local high schools, and want to attend college at in state tuition rates, AND achieve legal status.. The requirements are minimal and "children" up to age 35 can apply. At age 21 they could start to bring in their relatives. They will be eligible for government scholarships, our tax dollar at work! The Senate bill number is 729 and the House bill 1751. Please call your Senators and House member to let them know you are upset about this, and:

- 2. it will encourage people from around the world to send their children here to attend our free high schools and our public colleges, and
- 3. seats in our local colleges and universities are already in short supply.

JUDICIAL WATCH FIGHTS SANCTUARY CITIES

April 15 - Judicial Watch, a watchdog, non-profit, conservative organization, visited Mountain View to talk with a group of local citizens about the sanctuary activities of our local governments. Another big concern expressed was the public funding given to groups to provide employment centers for illegal workers and sanctuary policies that prevent police and other agencies from contacting Immigration and Customs Enforcement (ICE) about criminal matters.
