# **Chaos expected from DOMA decision**

It is truly a sad day when the U.S. Supreme Court rules against the will of the voters of California. Twice the voters of California have declared that marriage is between a man and a woman. Twice the successful grassroots efforts to pass Prop. 22 and later Prop. 8 were struck down by judges legislating from the bench.

Even more sadly, Republican office holders signed the Anti-Prop. 8 Amicus Brief urging the U.S. Supreme Court to overrule the voters of California. Those duly elected Republicans sought to force their view that gay marriage should be lawful rather than uphold a decision by the voters of California. The unintended consequence of their position jeopardizes the entire initiative process in California.

Brad Dacus, an attorney, and president of the Pacific Justice Institute, offered his views on the decision of the U.S. Supreme Court. Brad spoke to SVARW in May 2012. PJI's analysis of the blockbuster marriage ruling handed down on June 26 is reprinted below.

## Five key takeaways

The Supreme Court did not mandate gay marriage nationwide. LGBT activists are celebrating as though the marriage debate is over, and that's what they want you to believe. Not true! The Supreme Court did not give them the sweeping rulings they sought, and the court instead determined that this should continue to be decided at the state level, not on a national level. Because of the tortured way the Supreme Court arrived at its decision, there is much confusion, even among legal scholars, as to the immediate implications. The dissenting Justices seemed to believe that Judge Walker's original decision would be binding statewide, but many scholars have noted that such decisions typically are only effective as to the plaintiffs who actually filed suit. Expect a few more hotly-contested legal proceedings to sort out this mess created by the Supreme Court.

The Supreme Court did not approve or agree with any of the extreme reasoning used by Judge Vaughn Walker. As

to Prop. 8, the Supreme Court basically decided not to decide. They did not say that Judge Walker was correct, but rather that his decision could not be appealed since the Governor and Attorney General chose not to do so. We strongly disagree with the Supreme Court's extremely narrow view of standing, because it means the people cannot defend their own ballot initiatives. By adopting these narrow rules, jurists like Chief Justice Roberts may believe they are practicing judicial restraint, but in reality they are merely transferring it to lower courts.

The ruling against Prop. 8 jeopardizes the entire initiative process in California. Last month's disastrous ruling that Prop. 8 cannot be defended by its sponsors has implications far beyond gay marriage. As Justice Kennedy warned in his dissent (echoing a phrase we have been repeating the last several years), this gives the Governor and Attorney general a "de facto veto" over ballot initiatives they don't like. This is exactly why PJI filed suit after Judge Walker's decision, asking the California appellate courts to order the Governor and Attorney General to appeal that decision. At the time, the California Supreme Court dodged our request. Now ... they're realizing it could have averted this debacle by listening to us. Think about it ... if the Governor opposes a longstanding restriction like Prop. 13, or future ballot measures that would limit union power or require parental notification for abortions ... the special interests affected by such initiatives could simply file suit in federal court and get a default judgment. Every Californian—and citizens in the 26 other states with similar process—should be alarmed by this outrageous undermining of direct democracy.

The DOMA ruling will create chaos around the country. The Supreme Court's invalidation of part of the federal Defense of Marriage Act will begin to create problems immediately. The majority's stated belief that it could invalidate the federal law (in sweeping denunciations of supposed discrimination against gays), while at the same time leaving the states free to do as they please, is either dishonest or naive.


# Churches need to protect themselves

While dozens of "red" states are temporarily safe from being forced to accept gay marriage, it's hard to see how the dichotomy can be sustained for very long when citizens within those states are recognized as being married for purposes of taxes, benefits, immigration laws, etc. It's going to be a bumpy ride as more conservative states seek to stem the tide unleashed by the June 26 decision.

# Churches need to take immediate action to protect themselves from lawsuits.

Everywhere gay marriage has been adopted, First Amendment freedoms have been restricted. PJI fully expects a new round of harassment, intimidation, and discrimination against churches and individuals who continue to stand by their conscientious beliefs in traditional morality. For the past five years, we have been strongly encouraging churches to adopt model language we have drafted to protect against potential lawsuits from those who do not share the church's moral beliefs. If your church has not yet taken this step, please contact PJI immediately. Don't be caught off guard! Please also let us know if you face an imminent restriction of your free speech or religious freedom in the workplace or public square.
