President's message

War on freedom demands our action

Pacific Justice Institute attorneys keep First Amendment rights alive

For attorney Brad Dacus, no legal case is too small. President and founder of the Pacific Justice Institute, Dacus and his legal team work daily to preserve Americans’ constitutional rights, especially those enshrined in the First Amendment, which guarantees our freedom of speech and of worship.

Dacus told the audience at

SVARW’s November meeting about many of the successful legal cases his organization has handled. When one Bay Area city placed burdensome land use restrictions on a synagogue, Pacific Justice Institute was able to have those restrictions removed. PJI also joined in defending the national motto “In God We Trust.” In March 2010, the Ninth Circuit Court of Appeals unanimously agreed with PJI’s position that the motto is constitutional.

In explaining his philosophy, Dacus

compared PJI to a baseball batter who makes contact with every pitch.

“We don’t let anything go over the plate,” he said.

PJI’s willingness to take on small, local cases ensures that everyone has a place to turn when their First Amendment rights are under attack.
